GENERAL MANAGERS REPORT: Main pump is out.

Questions about this - is it safe?

Is it off and disconnected?

Is it closed and locked?

Could it be stolen?

JD confirmed it was closed and locked.

JD said that bore hole sucks air at a stage and then switches off

RR wanted to know if there was sinage in the bathroom to inform people about this and JD confirmed.

GE asked whether everyone had read all the reports.

GE says HR not up to standard and must be sorted out – contracts and all other matters pertaining to the staff.

BD offered assistance with HR.

RR stated that contracts needed assessment and he would like to hold a workshop on this.

FINANCES: On income statement GE mentioned IMPORTANT points, which are

to be seen on his budget statement – year to date. (see report)

He mentioned that certain areas were optimistic as apposed to reality.

e.g. restaurant, repairs and maintenance.

One of the concerns was the public loss.

Budget Meeting – not advertised there meeting post-phoned to 19 May 2017.05.14

There were some adjust to previous Budget meeting.

GE mentioned that FNB adverts and postings have been sent out and there has been quite a good response. Further details of the job, requirements, hours and what is expected of the applicant were to be sent out soon.

GE wanted JD to elaborate on the increases in budget for Repairs and Maintenance.

A discussion then ensued, with Grant going through each point and JD explaining: moving marker bouys

GE said that the kitchen definitely needs upgrading and the plan is to close it at a stage in the Winter, with the least invasion on members and guests.

BD said that there should be plans with future in mind.

GE said that they should seriously think of building 2 chalets – revenue.

Will they be aligned with members cabins – that means, have ablutions in or build another public ablution, which would ultimately cost more and who would pay for a cabin that does not include a toilet atleast.

BD felt that there was a need for member and public touch-points rather than pub so much money. Upgrading the ablutions would be of more benefit to all.

Further discussion about wish lists and GE stated that the Manager should have more input about what the key points were to upgrades and changes and that greater VISION was necessary. Do not just think now or for year ahead, must think long term as well.

RR had complaints of noise!

Many sites have changed hands, some changing member status.

According to the by- law, 8 stays are required per year. There are some who have not met this requirement and have written letter. There are however some who have simply ignored letters. RR does not want to be insensitive, but the by- laws are there as a guideline.

GE said they were not to be lenient as they are then setting a precedent and will make matters difficult for all in the future.

EVENTS: BD stated that the Voortrekkers would be coming in July again with 150 students. In September they would have a SUPER Ultra-Marathon again with more people and events for children. As there will no longer be a Synergy we need to canvass for other events.

GE there will be a SAS meeting at RCYC on Monday 8 th May to discuss calendar events and dates. We need our calendar dates to be sent to Lise so she can have them on hand.
